Complaints, criticisms and concerns against Appraisal District employees shall be directed through the appropriate channels in accordance with District policy. The presiding officer or designee shall determine whether a person who wishes to address the Board will be addressing an issue that is the subject of a hearing before the Board. If so, the Board may require that the comments be held and presented at the time of the hearing in order to comply with State law.
